Guidelines for Counseling and Vows

Premarital Counseling

Because of the present crisis in American marriages, the astronomical divorce rate, the devastating effects of divorce, and the deteriorating integrity in marriage, we *require* a minimum of three separate sessions of premarital counseling, from a **Christian Professional.** This is a "must" for all couples married at A.C.C.

Unless you are an Island resident, or on the Island frequently and are able to schedule counseling with one of our Pastors, we will allow you counsel with a Christian pastor, priest or marriage counselor in your area. Before beginning counseling we require you to submit the counselor's name and contact information so we may contact them to review the counseling requirements.

Prior to performing your ceremony we require verification that you have received such counseling; therefore a letter from your counselor is to be sent to us fifteen (15) days prior to the wedding otherwise we will be unable to perform the wedding.

Verification must be on letterhead of the church or agency, with return address, telephone number, and contact person. It shall contain the signature of the counselor certifying that he/she has met with you for a minimum of three sessions and has covered the following areas:

Commitment	Finances

Marriage Vows

Marriage, as it has been established by God, is recognized by this church to be exclusively the legal union of one man and one woman in a covenantal relationship. We regard the marriage vows as sacred in the sight of God, therefore, they are to be taken seriously. We ask you to read the following vows that will be used in your ceremony.

Should you wish to write your own vows we require that the vows affirm the points of commitment found in the vows that follow. We are happy to have you work with the Pastor to develop vows specific to your ceremony and marriage.

I, _____, take you _____, to be my wedded wife/husband, to have and to hold from this day forward, for better or for worse, for richer, for poorer, in sickness and in health, to love and to cherish, till death do us part, so help me God.

If you cannot wholeheartedly, without any reservation, submit to these vows, then we expect you to postpone your wedding day until you can.

These vows state that marriage is a permanent bond, "until death do us part." The wedding ceremony creates a "Oneness" that is no person should tear apart. We expect your desire for marriage to have the Oneness found in Matthew 19:5-6 "'For this cause shall a man leave father and mother and shall cleave to his wife, and the two shall be one flesh' Therefore they are no more two, but one flesh. What therefore God hath joined together, let not man put asunder."

Your return of the completed application communicates to us that you agree to the preceding and desire a Christian marriage ceremony.

May the Lord bless your decision.

The astronomical divorce rate, the devastating effects of divorce and the deteriorating integrity in marriage provides proof of the "crisis" status of marriage in America. It is because of this status, and because we at the Avalon Community Church regard marriage as sacred in God's sight, that premarital counseling is required of any couple wishing to be married by our pastors.

Since we cannot appropriately counsel from a distance, we have asked the couple desiring to be married to see a Christian professional such as a pastor, priest, psychologist, or other certified marriage counselor in their area. We require a minimum of three separate sessions of premarital counseling, covering the following topics:

Commitment	Finances
Communication	Roles and Responsibilities
Fidelity and Sexuality	Priorities and Decision Making
In-law Relationships	Planning for Parenthood

We know that we are taking a firm stand with these requirements. We feel that such a stand is necessary in the face of America's marriage crisis. We trust your counseling will reflect the serious concern we have to affirm in this couple the permanency of their marriage commitment and covenantal nature of their vows.

Prior to performing the ceremony for this couple, we require signed verification from you that they have received such counseling. This verification must be on letterhead of the church or agency responsible for the counseling, with return address, telephone number and contact person. The verification must be submitted to us at least thirty (30) days prior to the wedding date, otherwise we will be unable to perform the wedding.
